Atendiendo invitación del Reino de Arabia Saudita, en particular de los organizadores del evento de atracción de inversiones más grande del Medio Oriente, LEAP 2024 Into New Worlds, participamos como oradores en el panel titulado: The Future of Work, el día 4 de marzo.
